  - Retirement
    - There was a motion made in 2017 where the board approved a Longevity Bonus and Retirement Stipend which was not ever put in the handbook and has not been in practice
    - No one has retired so this has not impacted anyone at this time, however there are issues with the idea behind this motion as bonuses do not help contributions to the retirement system it is based on their base salary
    - Seems like the language needs to be changed
    - We have a person on the staff who has been at SCS for over 15 years but she did not receive the longevity bonus and another teacher who will have served their 15th year at the end of this school year
    - The board would like to take some time to research the law in order to adjust the motion to have the right language
    - Nicole will reach out to the School Board Association to see if they can advise us further
